# Q & A'S

**What areas do you service?**

I mostly perform in Central Western NSW but will travel anywhere in NSW for additional cost.

**What style of music do you play?**

My repertoire includes a variety of genres from classic rock, old school classics, contemporary country and modern hits. My break music is similar, although I will play a clients spotify set list on request.

**Do you need power for the ceremony package?**

Yes. Power is required to run the sound system.

**The ceremony is in a different area to the reception. Is that ok?**

Yes. If you commit to the "all day" package, I can play at up to 2 locations.

**Can you learn a song to play at my ceremony or bridal dance?**

Yes. If you would like me to perform your songs live (as opposed to mp3 on an ipad) I will require 4 weeks notice prior to the big day. Please note that my acoustic cover versions may be slightly different in style than the original version, but after all, that's the beauty of live music!

**Do you supply all your own equipment?**

Yes. For both the ceremony and reception I supply all sound and lighting equipment required. I can also supply a haze/smoke machine but please note some venues do not allow them, as they can trigger smoke alarms. I require a minimum 3 square meters for set up.

**Do I need to pay a deposit?**

A \$350 non-refundable deposit is required within 14 days to secure your date, with the balance to be paid 2 weeks before your special day. Payments are required via direct deposit.

**Do you need drinks or a meal?**

For all reception music packages, water, soft drinks and a supplier meal is to be provided.

**Do you play at private properties?**

No. I am only available for receptions at a licenced venue.

# TERMS AND CONDITIONS

## (PLEASE READ CAREFULLY)

1. A \$350 non-refundable deposit must be paid within 14 days to secure the booking. The remaining balance must be paid 14 days before the service is to be carried out. If any payment is not made within the times set forth herein, Shane Kerr may treat the contract as cancelled. Cancellation of this contract shall be as follows; a) Cancellation by the Client incurs a charge of \$350 (i.e., deposit paid is non-refundable). If however mandatory government restrictions are put in place and/or you need to make changes to your wedding due to COVID-19 restrictions, the deposit will be refunded in full. b) Between 1-14 days from the service date; the full fee will be payable and not refundable, unless due to mandatory government restrictions due to COVID-19. c) If full payment has been made and the contract is cancelled by the Client for unforeseen circumstances outside of the 14 day window, 50% of the full fee will be refunded. d) In the unlikely circumstance that the contract is cancelled by Shane (i.e. not the Client), a full refund of money paid is granted.
2. The Client accepts the terms and conditions of this Booking Contract if the Client, or someone on the Client's behalf: a) pays the deposit or full amount within 14 days; b) instructs Shane Kerr that the Client accepts it, whether in person or by post, telephone, fax, email or other form of communication.
3. The Client shall be responsible for the provision of mains electricity in the performance area (no generators), as well as a loading zone and parking space at the venue, at least one hour before, during and one hour after the event duration for Shane Kerr.
4. Shane Kerr agrees that the fee is inclusive of all expenses, holiday entitlements, tax contributions, and travelling expenses to and from the venue.
5. A supplier meal and water/soft drinks for Shane Kerr is required for all reception packages.
6. Shane Kerr warrants that a current Public Liability certificate is held, and that no part of the performance is likely to be a danger to himself or any other person/s.
7. Any losses of, or damage to the Shane Kerr's equipment, caused by a client or their guests will incur a full charge for restitution or repair.
8. Shane Kerr accepts no responsibility for non-fulfillment of the Booking Music, but every safeguard is assured.
9. Any additional changes to the original booking agreement will be invoiced by Shane Kerr accordingly.
10. Performance hours reduced in the instance of wet weather, delayed arrival of bridal parties, earlier closing of a venue or for any other reason will not be refunded.
11. Any late payments may result in cancellation of the contract.
12. Payments are to be made via Direct Deposit.
13. Photos of the event on, leading up to or after the day will be used on Shane Kerr's social media channels, website and any advertising material as required.
14. Quotes are valid for 14 days.
15. Additional hours are charged at \$350 per hour and are by the artists' discretion at all times. Additional hours must be pre-booked and paid for before the event date.
16. The wedding packages listed are the set price for weddings within a 150km radius of Cowra NSW.
17. Please note I do not perform at private properties.
18. All clients must sign a contract agreeing to the terms and conditions stated herein.
